#### Overview

- We supported candidates nationally as well as on the state level.
- We continued our outreach efforts to increase voter turnout.
- We have made great progress in educating our Willow Valley Residents.
- 2024 also saw the separation of Willow Valley Democrats Plus from the Lampeter-Strasburg Democratic Committee.

Willow Valley Democrats Plus has reason to celebrate some successes, but 2025 is showing that we have some challenging work ahead.

#### Membership

- Our membership as of December 2024 was 284.
- Our membership at the close of 2023 was 181.
- That increase of 103 members is due to the excellent work of Julia Powers.
- She encouraged the completion of a project to call all Democrats in Willow Valley, asking them to consider club membership.
- Julia and volunteers in the club made around 600 phone calls.

#### **Treasury**

- Our beginning balance for 2024 was \$3,373.51.
- Our ending balance was \$4,934.67 (\$ 1,500 difference).
- Our 2024 expenses were \$13,481.18.
- Our members were very generous with donations of \$ 8,035.07 which facilitated our outreach efforts and candidate support.
- Donation highlights:

May 27<sup>th</sup>: \$1000 each to our three local L-S candidates Bob Rudy State

House, Trex Proffitt State Senate, Jim Atkinson US Congress.

July 9<sup>th</sup>: \$1000 Scholarship to Bethany Helms.

August 29<sup>th</sup>: \$500 to Water Street Mission.

October 7<sup>th</sup>: \$2,000 Jim Atkinson, \$1,000 Trex Proffitt, \$1,000 Bob Rudy

November 24<sup>th</sup>: Bob Rudy returned \$350 of our donation.

#### **Communications**

- Lucy's excellent minutes of club meetings made the task of writing this address easier.
- Ross has published and distributed 11 electronic monthly club newsletters. She has also produced our slide presentations for our monthly club meetings and is currently developing our club website.
- Jerry hosted his monthly Understanding Our Democracy Series.

#### Communications (cont'd)

- Barbara coordinated postcard efforts for getting out the vote.
  - Seniors Taking Action
  - Moms Rising GOTV
  - Grandmothers for a Brighter Future
  - Fair Funding PA Schools.
  - We also mailed postcards to L-S voters who had not returned their mail-in ballots or had not requested their mail-in ballots.
- 202 volunteers completed 5,371 postcards.
- Julia surveyed club members in May asking for suggestions. 95
  questionnaires were returned and tabulated by Julia which
  was quite a task. This compilation has given our club
  guidelines for 2025 and beyond.

#### **Greeters**

Greeters make a huge difference at the polls. Democrats at our tables hand out sample ballots, answer questions and SMILE, giving a positive lift to voters.

- LOCUST: 28 at the Primary Election, 14 at the General Election.
- LAKES: There were 28 greeters at both our Primary Election and our General Election.
- In November, Lakes and Locust greeters were sent to four precincts outside of Willow Valley (Lyndon, Lampeter, Willow Street, and Strasburg).

#### Political Involvement

- We collected petition signatures to support Trex Proffitt, our write-in candidate for our State Senate seat.
- We collected signatures for our Democratic candidates on the Primary 2024 ballot.
- We mailed postcards to encourage L-S voter turnout and to support Bob Casey.
- We had members who canvassed throughout the Lampeter-Strasburg district.
- Kamala Harris won the Lakes precinct by 169 votes. Harris won Locust by 31 votes.

#### For the Record ...


- The IRS is holding up the official change of our name due to staffing shortages.

- Contact information for like-minded organizations will be available.



#### Bylaws of the Democratic Club of Willow Valley

#### **ARTICLE I: Name**

The name of the club shall be: The Democratic Club of Willow Valley; it is herein after referred to as "Club."

#### **ARTICLE II: Mission**

Our mission is to tackle bread-and-butter issues while protecting and lifting up our vulnerable populations via:

- Offering educational programs aimed at widespread issues;
- Providing guest speakers who can keep us informed;
- Endorsing local Democratic candidates and providing financial support;
- Offering a scholarship to local high-school students;
- Keeping our constituents informed through monthly newsletters;
- Promoting more progressive legislation and government at all levels.

#### **ARTICLE III: Membership**

All eligible voters, regardless of party affiliation, who support the purpose of the Club, who are Residents of Willow Valley or SmartLife members, and who reside in the Lakes or Locust precincts are qualified for membership. Interested parties may request membership in the Club to any of its officers. All members are requested to show their commitment to the Club by making an annual, voluntary financial contribution. Any contribution is welcome, but a suggested amount will be determined by the Executive Board. Membership in the Club entitles paid-up members to vote on officers and vote on changes to these bylaws.

#### **ARTICLE IV: Officers/Executive Board**

The Club shall be led by an Executive Board that is empowered to take such actions as are necessary to carry out the purpose of the Club.

The Executive Board shall consist of the President, Vice President, Treasurer, and Secretary. All officers shall be elected by members and will serve for a term of two years.

 The Vice President shall assist the President in program planning and execution and fulfilling the duties of the President when the President is unavailable. The Vice President may approve expenditures.

Committees and their leaders are appointed by the President. The committee leaders may become part of the Executive Board upon approval by the Officers; they shall then participate and vote in meetings.

#### **ARTICLE V: Elections**

Officers shall be members of the Club serving two-year terms. They are normally elected at the first meeting of the calendar year. The President and Secretary shall be elected in even-numbered years; the Vice President and Treasurer shall be elected in odd-numbered years. The Executive Board will nominate a slate of candidates that will be distributed by email to the membership at least two weeks prior to the election meeting. At the meeting at which any election takes place nominations from the floor will be entertained. Officers may serve multiple terms. In the event that a vacancy does occur, the officer chosen to fill that position shall be appointed by the President and will serve for the remainder of that term.


